What is this product?

Type

This product is an investment fund. Selection Japan Equity is a sub-fund of Architas Multi-Manager Global Funds Unit Trust, an open-ended unit trust with segregated liability between its sub-funds authorised by the Central Bank of Ireland pursuant to the provisions of the UCITS Regulations/the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011 (S.I. No. 352 of 2011), as may be amended from time to time.

Objectives

Investment objective The aim of the Fund is to increase the value of your investment through investment in a diversified and actively managed portfolio of shares and share-related securities.

Investment policy The Fund is actively managed and will invest at least two-thirds in securities domiciled, listed, quoted or traded on regulated markets in Japan. The Fund may also invest up to 30% in share-related securities and in companies established outside of Japan.

Subject to the above, the Fund is not subject to any limitation on the proportion of its net asset value that may be invested in any one country or sector. Investment in other funds is limited to 10% of the Fund's assets.

Benchmark use The Fund is actively managed. The Fund is measured against the Topix benchmark. The Investment Manager has the freedom to invest in securities that are not part of the benchmark.

Redemption and Dealing Units of the Fund may be redeemed on demand, with dealing normally on a daily basis.

Distribution Policy We will automatically include income from the Fund's investments in the value of your units.

Intended retail investor

This product is suitable for investors seeking to achieve long term capital appreciation measured in Japanese Yen with a medium to high level of volatility.

Term

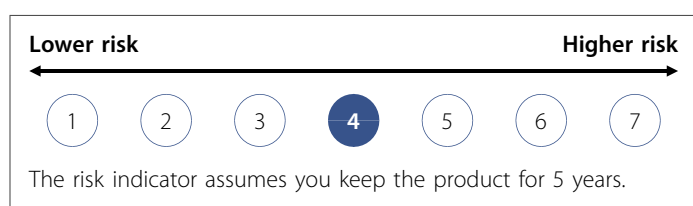
The Fund has no maturity date. All the units of the Fund may be redeemed at the discretion of Architas Multi-Manager Europe Limited, if, after the first anniversary of the first issue of the Units in the Fund, the Net Asset Value of the Fund falls, for a period of 30 consecutive days or more, below €840,000 or its foreign currency equivalent. A unitholder notification will be sent at least one month prior to the actual termination date.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of Architas Multi-Manager Europe Limited to pay you.

Be aware of currency risk. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable: this type of scenario occurred for an investment between July 2015 and July 2020.

Moderate: this type of scenario occurred for an investment between September 2014 and September 2019.

What happens if Architas Multi-Manager Europe Limited is unable to pay out?

For your protection the fund's assets are held with a separate company, a depositary, so the fund's ability to pay out would not be affected by the insolvency of Architas Multi-Manager Europe Limited. If the fund is terminated or wound up, the depositary would liquidate the investments and distribute the proceeds to investors. You may lose part or all of your investment. You are not covered by any national compensation scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 JPY is invested.

Recommended holding period: 5 years
