What is this product?

Type

This product is an investment fund. AXA Selection AllianceBernstein Dynamic Diversified is a sub-fund of Architas Multi-Manager Global Funds Unit Trust, an open-ended unit trust with segregated liability between its sub-funds authorised by the Central Bank of Ireland pursuant to the provisions of the UCITS Regulations/the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011 (S.I. No. 352 of 2011), as may be amended from time to time.

Objectives

Investment objective The aim of the Fund is to maximise the return from your investment.

Investment policy The Fund is actively managed and will invest globally in multiple asset classes such as shares, tradable debt (bonds), financial contracts (derivatives) and other funds. Indirect exposure to real estate and commodities may be obtained through investment trusts, derivatives and shares. The allocation between asset classes will be managed dynamically, although under normal market conditions it is expected that the fund will mainly be invested in shares. Investments may include the use of shares and derivatives which are linked to credit risk or interest rates. The Fund may invest in shares, bonds and other forms of tradable debt listed or traded on a regulated exchange. The bonds which the Fund invests in, which will either pay fixed or variable interest, are issued by companies and public bodies, some of which are given a rating by a recognised rating agency which takes into account factors such as creditworthiness. The Fund may only invest up to 30% of its assets in bonds which are unrated or which have a relatively higher risk of default (non-investment grade); or 30% of its assets in bonds linked to underlying mortgages or other assets. The Fund may also invest up to 30% of its assets in emerging markets.

Investment in other funds is limited to 10% of the Fund's assets. The Fund may also invest in derivatives under which the return on one asset will be swapped for the return on another asset (swaps). Swaps are used to enable the Fund to offset potential losses that may be incurred by other investments made (hedging) as well as to give the Fund access to

investments which are not otherwise readily accessible.

Where the use of swaps results in the Fund holding a substantial portion of its assets in cash, the investment manager may invest this cash on a discretionary basis.

Benchmark use The Fund does not have a benchmark.

Redemption and Dealing Units of the Fund may be redeemed on demand, with dealing normally on a daily basis.

Distribution Policy We will automatically include income from the Fund's investments in the value of your units.

Intended retail investor

This product is suitable for investors seeking to maximise total return with a medium level of volatility.

Term

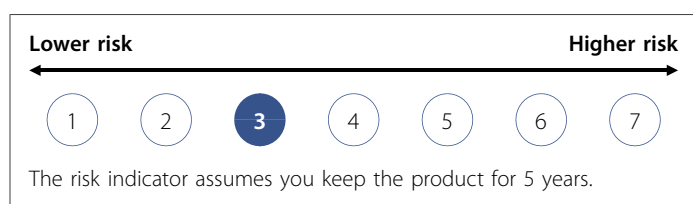
The Fund has no maturity date. All the units of the Fund may be redeemed at the discretion of Architas Multi-Manager Europe Limited, if, after the first anniversary of the first issue of the Units in the Fund, the Net Asset Value of the Fund falls, for a period of 30 consecutive days or more, below €840,000 or its foreign currency equivalent. A unitholder notification will be sent at least one month prior to the actual termination date.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of Architas Multi-Manager Europe Limited to pay you.

Be aware of currency risk. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product over the last 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable: this type of scenario occurred for an investment between December 2021 and September 2023.

Moderate: this type of scenario occurred for an investment between February 2017 and February 2022.

What happens if Architas Multi-Manager Europe Limited is unable to pay out?

For your protection the fund's assets are held with a separate company, a depositary, so the fund's ability to pay out would not be affected by the insolvency of Architas Multi-Manager Europe Limited. If the fund is terminated or wound up, the depositary would liquidate the investments and distribute the proceeds to investors. You may lose part or all of your investment. You are not covered by any national compensation scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.
