## What is this product?

### Type

This product is a share class of AXA INVESTPLUS BONDS CORE, itself a sub-fund of AXA INVESTPLUS, an investment company with variable share capital and is governed by Luxembourg law.

### Objectives

**Investment objective** The Fund invests mainly in other funds invested in turn in worldwide bond markets. For performance comparison purposes only, the Sub-Fund uses a benchmark composed of 50% of the performance of the Morningstar Global Core Bond TR Hedged EUR Index, 40% of the Morningstar Eurozone Core Bond TR EUR Index and 10% of the Morningstar Eurozone Corporate Bond TR EUR Index.

**Investment policy** The Fund is an actively managed fund of funds. Selection of investments follows a 'top down' approach determined by the Investment Manager, with a focus on funds whose performance does not deviate significantly from their benchmarks. The Fund will comprise shares and units in other funds covering mainly government and corporate investment grade bond markets, whether traditional or emerging, and which may, to a lesser extent, be exposed to non-investment grade and/or defaulted debt securities. Although the Fund is not subject to any limitation on the portion of its assets that may be exposed to any one asset class, it is expected to be mainly (greater than 50%) exposed to investment grade corporate and government Fixed Income Securities, whether through investment in other funds or through direct investment.

The Investment Manager will use its extensive research (including investment due diligence and analysis, examining both qualitative and quantitative criteria) and market insight to seek out opportunities for outperformance through selection of the best funds available, as determined by the Investment Manager in its discretion.

The Investment Manager may invest up to 30% of the net assets of the Fund directly in other investments (including mainly Fixed-Income Securities).

The Fund may also invest up to 10% of its net assets in bank deposits, money market instruments or money market funds.

The Fund is a financial product that promotes environmental and/or social characteristics within the meaning of article 8 of the Regulation (EU) 2019/2088 of 27 November 2019 on sustainability-related disclosures in the financial sector.

**Benchmark use** The Fund is actively managed. The Fund is measured against 50% of the performance of the Morningstar Global Core Bond TR Hedged EUR Index, 40% of the Morningstar Eurozone Core Bond TR EUR Index and 10% of the Morningstar Eurozone Corporate Bond TR EUR Index benchmark. The Investment Manager has the freedom to invest in

securities that are not part of the benchmark. The Fund may deviate significantly from the benchmark.

**Redemption and Dealing** Shares of the Fund may be redeemed on demand, with dealing normally on a daily basis.

**Distribution Policy** For Accumulation share classes (Acc), the dividend is reinvested.

### Intended retail investor

This product is suitable for investors seeking to maximise total return from income and capital growth over a medium to long-term horizon and who are willing to accept a low to medium level of volatility.

### Terms to understand

**Bonds:** Securities that represent a right to receive repayment of a debt along with interest.

**Quantitative and qualitative criteria:** measurable/verifiable and abstract/ interpretive criteria.

### Practical information

**Depositary** The fund depositary is BNP PARIBAS, Luxembourg Branch, 60, Avenue J.F. Kennedy, L-1855 Luxembourg, Grand Duchy of Luxembourg.

### Term

The Fund has no maturity date. The fund may be liquidated at the discretion of the Board of Directors if the net assets of the fund fall below EUR 1,250,000. The decision to liquidate shall be published or communicated to shareholders before the effective date of the liquidation.

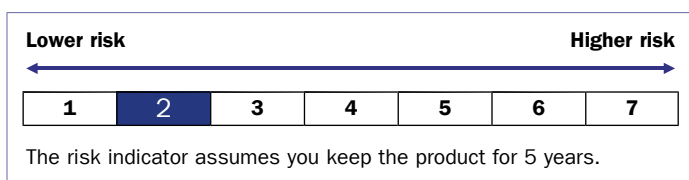
**Switching between Funds:** Shareholders may apply for any share classes of any Funds to be converted into share classes of another Fund, provided that the conditions for accessing the target share class, type or sub-type are fulfilled with respect to this Fund, on the basis of their respective Net Asset Value calculated on the Valuation Day following receipt of the conversion request.

The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus.

## What are the risks and what could I get in return?

### Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of AXA Investment Managers Paris to pay you.

Be aware of currency risk. You may receive payments in a different currency, so the final return you will get depends on the exchange rate

### Performance scenarios

### What happens if AXA Investment Managers Paris is unable to pay out?

For your protection the fund's assets are held with a separate company, a depository, so the fund's ability to pay out would not be affected by the insolvency of AXA Investment Managers Paris. If the fund is terminated or wound up, the depository would liquidate the investments and distribute the proceeds to investors. You may lose part or all of your investment. You are not covered by any national compensation scheme.

### What are the costs?

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

## How long should I hold it and can I take money out early?

## Recommended holding period: 5 years

This product is designed to be a long term investment; you should be prepared to stay invested for at least 5 years.
