What is this product?

Type

This product is a share class of AXA INVESTPLUS EQUITY CORE, itself a sub-fund of AXA INVESTPLUS, an investment company with variable share capital and is governed by Luxembourg law.

Objectives

Investment objective The Fund invests mainly in other funds invested in turn in worldwide stock exchanges. For performance comparison purposes only, the Sub-Fund uses a benchmark composed of 12% of the performance of the Morningstar Developed Markets Europe Target Market Exposure NR EUR Index, 47% of the Morningstar US Target Market Exposure NR EUR Index, 25% of the Morningstar Developed Markets Eurozone Target Market Exposure NR EUR Index, 25% of the Morningstar Developed Markets Eurozone Target Market Exposure NR EUR Index, 10% of the Morningstar Emerging Markets Target Market Exposure NR EUR Index and 6% of the Morningstar Developed Markets Asia Pacific Target Market Exposure NR EUR Index.

Investment policy The Fund is an actively managed fund of funds. Selection of investments follows a 'top down' approach determined by the Investment Manager, with a focus on funds whose performance does not deviate significantly from their benchmarks. The Fund will comprise shares and units in other funds covering mainly large-cap stocks listed or traded on world stock exchanges, whether traditional or emerging.

The Investment Manager will use its extensive research (including investment due diligence and analysis, examining both qualitative and quantitative criteria) and market insight to seek out opportunities for outperformance through selection of the best funds available, as determined by the Investment Manager in its discretion.


The Investment Manager may invest up to 30% of the net assets of the Fund directly in other investments (including mainly equities and Equity Related-Securities).

The Fund may also invest up to 10% of its net assets in bank deposits, money market instruments or money market funds.

The Fund is a financial product that promotes environmental and/or social characteristics within the meaning of article 8 of the Regulation (EU) 2019/2088 of 27 November 2019 on sustainability-related disclosures in the financial sector.

Benchmark use The Fund is actively managed. The Fund is measured against 12% of the performance of the Morningstar Developed Markets Europe Target Market Exposure NR EUR Index, 47% of the Morningstar US Target Market Exposure NR EUR Index, 25% of the Morningstar Developed Markets Eurozone Target Market Exposure NR EUR Index, 10% of the Morningstar Emerging Markets Target Market Exposure NR EUR Index and 6% of the Morningstar Developed Markets Asia Pacific Target Market Exposure NR EUR Index benchmark. This product is suitable for investors seeking to maximise total return from income and capital growth over a medium to long-term horizon and who are willing to accept a medium to high level of volatility.

Term

The Fund has no maturity date. The fund may be liquidated at the discretion of the Board of Directors if the net assets of the fund fall below EUR 1,250,000. The decision to liquidate shall be published or communicated to shareholders before the effective date of the liquidation.

What happens if AXA Investment Managers Paris is unable to pay out?

For your protection the fund's assets are held with a separate company, a depositary, so the fund's ability to pay out would not be affected by the insolvency of AXA Investment Managers Paris. If the fund is terminated or wound up, the depositary would liquidate the investments and distribute the proceeds to investors. You may lose part or all of your investment. What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

How long should I hold it and can I take money out early?
