What is this product?

Type

This product is a share class of AXA INVESTPLUS EQUITY CORE, itself a sub-fund of AXA INVESTPLUS, an investment company with variable share capital and is governed by Luxembourg law.

Objectives

Investment objective The Fund invests mainly in other funds invested in turn in worldwide stock exchanges. Its objective is to outperform a benchmark composed of 45% of the performance of the MSCI World 100% Hedged to EUR Index, 20% of the MSCI World EUR Index, 25% of the MSCI EMU EUR Index and 10% of the MSCI Emerging Markets EUR Index, while at the same time consistently reproducing movements in world equity markets at all times.

Investment policy The Fund is an actively managed fund of funds. Selection of investments follows a 'top down' approach which is largely determined by the Manager. The Fund will comprise shares and units in other funds covering mainly large cap stocks listed or traded on world stock exchanges, whether traditional or emerging. The Manager will select the best equity funds available on the basis of quantitative and qualitative criteria. The Fund will thus include a number of lines, so that the investments can be diversified geographically and in terms of sectors using the open architecture principle.

The Manager may invest up to 30% of the net assets of the Fund in investments other than shares and units in other funds.

Cash and cash equivalents may never exceed 10% of the net assets of the Fund.

Benchmark use The Fund is actively managed. The Fund is measured against 45% of the performance of the MSCI World 100% Hedged to EUR Index, 20% of the MSCI World EUR Index, 25% of the MSCI EMU EUR Index and 10% of the MSCI Emerging Markets EUR Index benchmark. The Investment Manager has the freedom to invest in securities that are not part of the benchmark. The Fund may deviate significantly from the benchmark

Redemption and Dealing Shares of the Fund may be redeemed on demand, with dealing normally on a daily basis.

Distribution Policy For Accumulation share classes (Acc), the dividend is reinvested.

Intended retail investor

This product is suitable for investors seeking to maximise total return from income and capital growth over a medium to long-term horizon and who are willing to accept a medium to high level of volatility.

Terms to understand

Quantitative and qualitative criteria: measurable/verifiable and abstract/ interpretive criteria.

Stocks/Equity: Securities that represent a fractional ownership in a company.

Term

The Fund has no maturity date. The fund may be liquidated at the discretion of the Board of Directors if the net assets of the fund fall below EUR 1,250,000. The decision to liquidate shall be published or communicated to shareholders before the effective date of the liquidation.



What are the risks and what could I get in return? Risks

What happens if AXA Investment Managers Paris is unable to pay out?

What are the costs?
